Subject: Filling up of posts in National Green Tribunal on deputation basis.

Sir,

This is in reference to your department's letter no. 17(6)/2012-PL/NGT dated 03.05.2013 and in continuation to my earlier letter No. NGT(PB)59/RR/2013 dated 22nd April, 2013 inviting applications from the eligible and suitable officials for appointment to the post of Private Secretary, Steno Group-C/ Court Master and Steno Group - D in the National Green Tribunal, Principal Bench at New Delhi and Zonal Benches at Bhopal, Chennai, Pune and Kolkata on deputation basis.

2. This is to inform your goodself that, as desired, in order to enable the candidates to submit their applications for deputation posts through proper channel, the last date of receipt of applications for the deputation posts is extended till 27th May, 2013. It is also clarified that the upper age limit for the applicants for deputation posts is 56 years as per Rule 11 of the National Green Tribunal (Recruitment, Salaries and other Terms and Conditions of Services of Officers and other Employees) Rules, 2011, already available alongwith the advertisement on the website of the National Green Tribunal, and that the number of deputation posts of P.A (Stenographer Grade C)/Court Master is 10.

3. Necessary Corrigendum No. NGT(PB)59/RR/2013 dated 04.05.2013 in this regard has also been published in the The Times of India & NavBharat Times in their Delhi edition and The Hindu in its Chennai edition. The details of these posts, essential qualifications and other eligibility conditions etc. as contained in the RRs are also available on the website of National Green Tribunal (www.greentribunal.in) and Ministry of Environment & Forests' website (www.moef.nic.in/www.envfor.nic.in).

4. As already intimated, applications of only such officials / candidates will be considered as are routed through proper channel and are accompanied by (i) Photocopies of ACRs for the last five years attested on each page by an officer not below the rank of Under Secretary to the Government of India level, (ii) Vigilance Clearance Certificate, (iii) Integrity Certificate, (iv) No penalty Certificate and a statement giving details of major/minor penalties imposed on the officer, if any, during the last 5 years. It may also be verified and certified that the particulars furnished by the officers are correct.

5. It is, therefore, requested that the applications of suitable and eligible officers and who can be spared immediately in the event of selection may be sent directly to the National Green Tribunal, Van Vigyan Bhawan, Sector V, R.K. Puram, New Delhi-110022 by the extended date i.e. 27th May, 2013.

6. Advance copies of applications or received after the prescribed closing date or not accompanied with the required certificates/documents are liable to be rejected.

7. This letter may kindly be given wide publicity in Departments/Organizations of your Ministry and other Ministries of the Government of India and may also be uploaded on the Ministry of Environment & Forests website.
