 - the officer who has not completed/undergone level 'D' Training of the CSS shall require to undergo and successfully complete the level 'D' Training within a period of six months;
 - The ad-hoc promotion of officer/s shall be subject to the final outcome in the OA No. 3294/2009 titled Shri P.R. Sharma vs. UOI and OA No. 2674/2009 titled Shri P.S. Bhandari vs. UOI & ors. Pending before the CAT, New Delhi.
