**Subject: Inviting applications for appointment to the post of Judicial Member and Expert Member in the National Green Tribunal**

The Government of India has enacted the National Green Tribunal (NGT) Act, 2010 (19 of 2010) for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources including enforcement of any legal right relating to environment and giving relief and compensation for damages to persons and property and for matters connected therewith or incidental thereto. As per Section 3 of the NGT Act, the Central Government has established the National Green Tribunal. It is proposed to fill up the posts of Judicial and Expert Members as per the provisions of the NGT Act, 2010.

Applications are invited from eligible Indian citizens for the following posts of Members, National Green Tribunal:-

(i) Judicial Member -10(ten) posts

(ii) Expert Member - 10(ten) posts

**Method of recruitment** – The method of recruitment of Member shall be by direct recruitment on contract basis:

Provided that any person in service in the Government or an Autonomous body or a Statutory body or a University may opt for appointment either by direct recruitment or on deputation basis:

Provided further that no person shall be appointed on deputation, unless he holds an analogous post on regular basis or a post which is one level below that of analogous post.

In case of a sitting Judge of the Supreme Court or a High Court who is appointed as the Judicial Member, his service in the Tribunal shall be treated as actual service within the meaning of sub-clause (i) of clause(b) of paragraph 11 of Part D of the Second Schedule to the Constitution.

The eligibility, term of office, salary & allowances and other conditions of service for the post of Member of the Tribunal are given below:

**Qualification:** The qualifications and other requirements for the Judicial and Expert Members are as under:

**Member (Judicial):** A person shall not be qualified for appointment as a Judicial Member of the Tribunal unless he is, or has been (a) a Judge of the Supreme Court of India; or (b) Judge of High Courts.

**Member (Expert):** A person shall not be qualified for appointment as an Expert Member, unless he:

- (a) has a degree in Master of Sciences (in physical sciences or life sciences) with a Doctorate degree or Master of Engineering or Master of Technology and has an experience of 15 (fifteen) years in the relevant field including 5 (five) years practical experience in the field of environment and forests (including pollution control, hazardous substance management, environment impact assessment, climate change management, biological diversity management and forest conservation) in a reputed National level institution; or
- (b) has administrative experience of 15 (fifteen) years including experience of 5 (five) years in dealing with environmental matters in the Central or a State Government or in reputed National or State level institution.

**Term of Office:**

- (i) A Judicial Member of the National Green Tribunal shall hold office for a term of 5 (five) years from the date on which he joins his office.

Provided that in case a person, who is or has been a judge of the Supreme Court, has been appointed as Judicial Member of the Tribunal, he shall not hold office after he has attained the age of 70 (seventy) years.

Provided further that in case a person, who is or has been the Chief Justice of a High Court, is appointed as Judicial Member of the Tribunal, he shall not hold office after attaining the age of 67 (sixty-seven) years.

Provided further that in case a person, who is or has been a Judge of a High Court, is appointed as Judicial Member of the Tribunal, he shall not hold office after attaining the age of 67 (sixty-seven) years.

- (ii) An Expert Member of the National Green Tribunal shall hold office for a term of 5 (five) years from the date on which he enters upon his office or until he attains the age of 65 (sixty-five) years, whichever is earlier.

**Salary & Allowances and other conditions of service**

**Salary and allowances :**

- (i) the Judicial Member shall be entitled to a monthly salary of Rs. 80,000/-(Eighty Thousand) (fixed) and to such allowances as are admissible to a sitting judge of a High Court; and

(ii) the Expert Member shall be entitled to a monthly salary of Rs.80,000/- (Eighty Thousand) (fixed) and to such allowances as are admissible to a Secretary to the Government of India:

Provided that in case a person appointed as a Member, is drawing any pension, the pay of such person shall be reduced by the gross amount of pension drawn by him:

Provided further that a Member shall be entitled to draw allowances on the original basic pay before such fixation of pay.

**House Rent Allowance:**


A Judicial Member or an Expert Member shall have the option of claiming house rent allowance at the rate of 30% (thirty per cent) of the basic pay drawn:

Provided that he shall not be eligible for house rent allowance in case he is declared eligible for General Pool Residential Accommodation in Delhi.

Eligible and interested persons may submit their applications in the prescribed format (Annexure- I) to Smt. Sunita Singh, Director, Room No. 717, Paryavaran Bhavan, CGO Complex, Lodhi Road, New Delhi-110003 on or before 13<sup>th</sup> JANUARY 2011. Those who are working in the Supreme Court/High Court/Central / State Government/ Autonomous Bodies/ PSUs /Universities may send their application through proper channel along with photocopies of the ACRs/APARs of the last five years, as applicable. While forwarding the application, it may be certified that no disciplinary proceedings or vigilance case is either pending or contemplated against the applicant. The integrity of the applicant may also be certified by the Competent Authority.

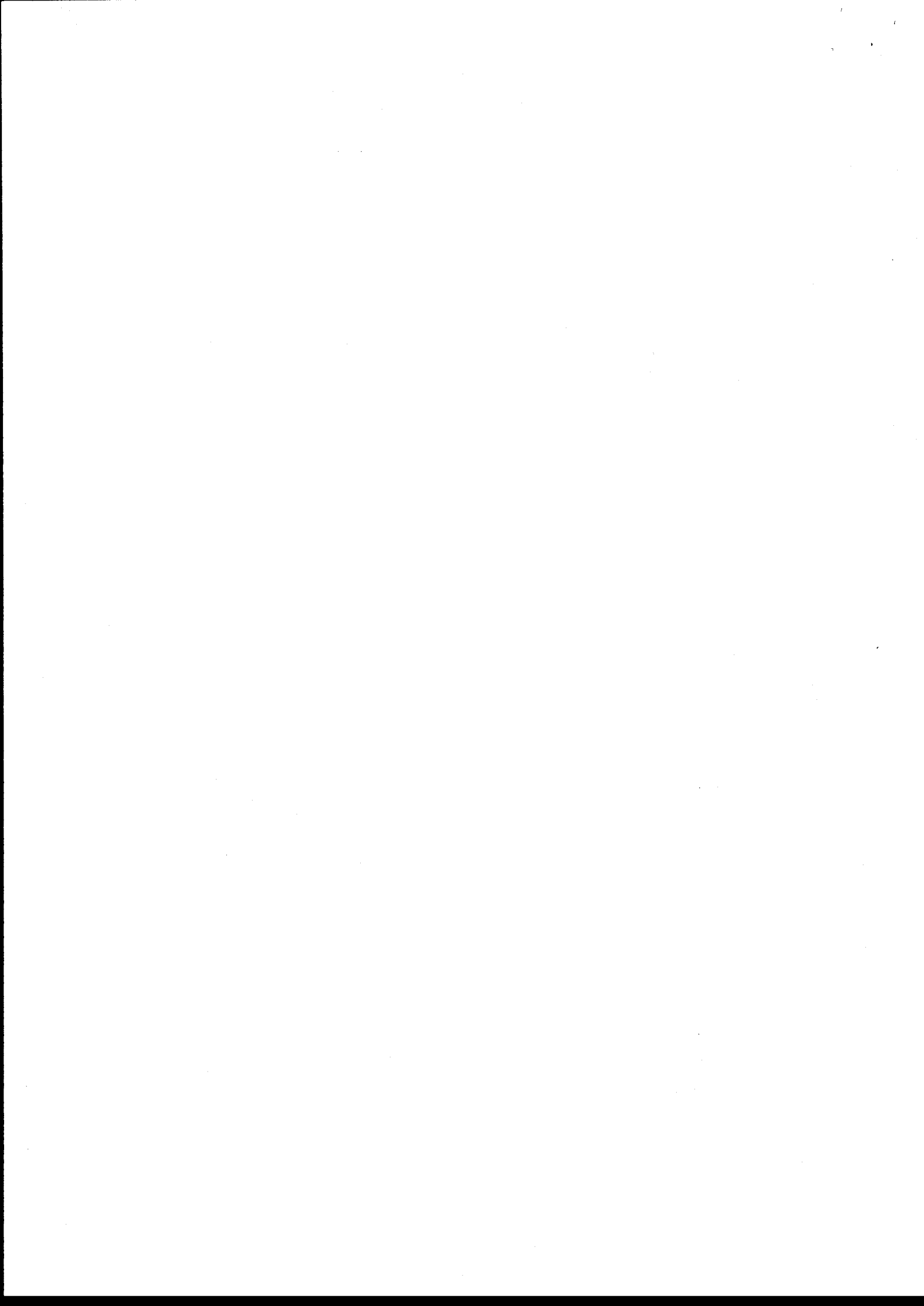
Applications which are incomplete or not in the prescribed format or not accompanied with the details as mentioned above shall not be entertained and would be liable to be summarily rejected.
