**TENDER FOR REPAIR AND ANNUAL MAINTENANCE
CONTRACT FOR DIESEL OPERATED INCINERATOR
INSTALLED AT NATIONAL ZOOLOGICAL PARK FOR
THE YEAR 2011-12.**

1. Sealed tenders are invited from interested individuals/firms/companies having experience of minimum three years or more in executing & repair work of diesel operated incinerator for a period of one year w.e.f 1.12.2011 to 30.11.2012 as per terms and conditions as detailed in the following paragraphs.

2. Working hours : **9.00 A.M. TO 6.00 P.M.**

3. Settlement of disputes: In the matter of any disputes, between the parties regarding the terms and conditions of the contract and execution thereof, the matter shall be referred to an arbitrator(s) as may be decided by the Director, National Zoological Park for arbitration under the Arbitration and conciliation Act,1986. The contractor shall not question the decision of the Arbitrator(s) on ground that the Arbitrator(s) shall be final and binding on the parties.

4. The submission of the tender will mean that the bidder has full knowledge of scope of work and all the terms and conditions of the works.

5. Bills shall be submitted by the tenderer at the end of each month (in triplicate) alongwith certificates thereon from the officer-in-charge of the work about the satisfactory performance in support of having performed the job. This certificate shall be counter signed by Estate Supervisor / Section Officer.

6. The Director, National Zoological Park, can terminate the contract at any time, after serving fifteen days notice to the contractor if during the tenure of the contract, the performance is not found satisfactory. The decision of the Director National Zoological Park shall be final and binding on the service provider in this regard.

7. All spare parts shall be brought and fitted by the tenderer at his own cost. A qualified Engineer of the company must check and service the incinerator at least two times in a month and they should also attend the complaints as and made by this office within 24 hours of lodging the complaint. All repair and related works in the incinerator shall be executed by the tenderer only.

8. Failure by the contractor to comply with any statutory requirements during the period of contract shall result in termination of the contract and subsequent disqualification for participation in any future tender in the National Zoological Park.

9. In any time during the period of contract it comes to the notice of the Director, National Zoological Park that the contractor has misled the Director, National Zoological Park by way of giving incorrect/ false information, which has been material in the award of contract to him/her, the contract shall be liable for termination besides other legal action may be initiated against him/her under laws.

10. The successful tenderer shall provide all necessary equipment/ implements and other tools to his persons for satisfactory performance of the work.

11. The successful tenderer shall submit a list of his persons to the officer in-charge of the works for issuance of gate pass for entry inside the zoo after getting the work order.

12. The contractors have to submit the sealed tender upto 3.00 P.M. on 11.11.2011 in the prescribed proforma quoting his rate clearly without any condition therein for the work mentioned above in National Zoological Park premises from 9.00 A.M. to 6.00 P.M.

13. An amount of Rs. 5,000/- (Rupees five thousand only) as Earnest Money must be deposited in the form of demand draft in favour of Director, National Zoological Park, New Delhi from a nationalized bank alongwith the tender form failing which the tender will be rejected on the spot. The Earnest Money will be forfeited to Government if:

- i) The contractor failed to submit security deposit by the due date.
- ii) Withdraw the tender/ dishonour in the event of its acceptance by National Zoological Park.

14. The successful tenderer has to submit a security deposit of Rs. 25,000/- (Rupees twenty five thousand only) in the form of fixed deposit in the nationalized bank. The security deposit would be refunded after successful completion of the tender period. In case of any breach of conditions and violation of terms and conditions or unsatisfactory performance, the security deposit would be forfeited to the Government. The decision of the Director, National Zoological Park would be the final and binding on this matter.

15. The Director National Zoological Park shall have the right to cancel the tender at any time without any reasons. In other words, the tender can be cancelled at any time period between 1.12.2011 to 30.11.2012.

16. The tenderer has to attach the photocopy of the Income Tax Clearance certificate/PAN Card, Ration Card, Voter's Identity Card and any other documents mentioned in the tender.

17 The Director National Zoological Park is not bound to accept the lowest tender. He reserves the right to accept highest or lowest tender at his own discretion.

18. Any clause of tender can be cancelled /modified or altered at any time during the course of period mentioned above at the discretion of the Director National Zoological Park and the tenderer has to accept the altered or modified conditions.

19. In all matters the decision of the Director National Zoological Park is final and binding on both the parties.

20. The successful tenderer shall have to execute an agreement in the prescribed proforma within ten days after the award of the work.

21. The payment shall be released upto 25th of every month for the period pertaining to previous month. In other words, the payment for October shall be paid upto 25th November. However, it is not possible that sometime for want of funds, it may not be possible to pass the bill and make the payment for the months together, in that case no interest / compensation shall be payable or considered. The tenderer shall have to make the payment of wages to the labourer engaged by him from his own sources in all such eventuality and he shall not take the plea that the payment shall be made after clearance of his bill.

22. The contractor is fully responsible for the safety of the person deputed by him. The NZP will not accept any liability for the injury caused on account of the animal attack, mis-happening or any other occurrence or the contractor himself shall be responsible for the compensation, if any. Medical treatment and expenditure thereon shall be born by the contractor himself. Police case, Court cases, if any, institute by the aggrieved party shall be dealt by the contractor himself. The NZP is not responsible on this matter.

23. The income tax will be deducted as per existing rules from the payment of tenderer.

24. The Director National Zoological Park may terminate the contract at any time without any compensation by notice in writing if the contractor commits any breach of contract.

25. The period of contract will initially be for one year w.e.f. 1.12.2011 to 30.11.2012 and on successful of one year of the contract, the contract may be renewed further on year to year basis subject to satisfactory performance and contractor's on the same rate at the discretion of Director National Zoological Park.
